PORTFOLIO AIMS

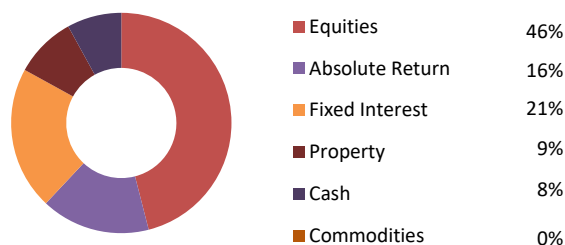
