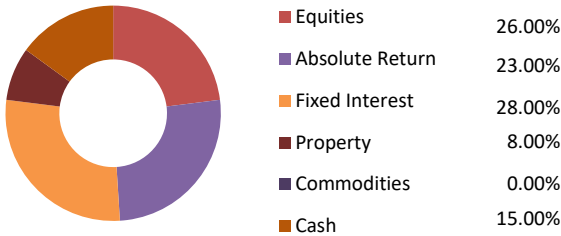

To achieve this level of return, the portfolio will invest in asset classes which will introduce fluctuations in capital value over the short and medium term.
