

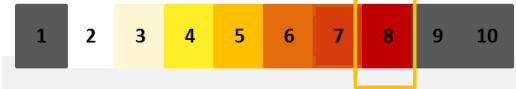

While this is a higher risk, and predominantly equity-based portfolio it will at times have exposure to other assets where we see compelling valuations, special situations, themes or geographical opportunities.

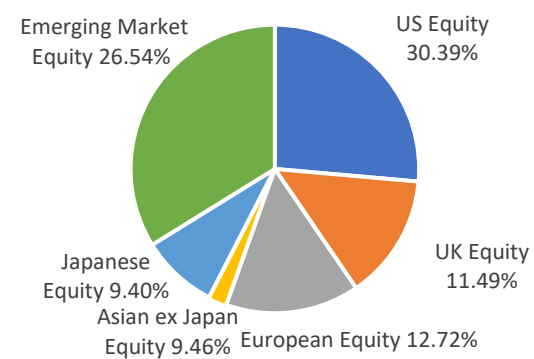
